ν Rad's physician credentialing, licensing & privileging service provides you with the benefits of a Credentials Verification Organization (CVO) without the cost.

If your hospital bylaws allow a CVO or accredited telemedicine entity for credentials verification (CV), you can rely on ν Rad's Credentialing, Licensing and Privileging (CLP) teams to relieve your Medical Staff Office of almost all CV activity related to ν Rad's providers. As a Joint Commission-accredited ambulatory care facility, ν Rad will be the "distant-site" telemedicine provider of contracted services to your hospital.



We have maintained The Joint Commission Gold Seal of Approval® since 2004. Our verification processes go above and beyond standard expectations of technical competency review. All radiologists are fully credentialed and are subject to an internal board review and approval at initial appointment and reappointment.

uRad's CLP teams consist of 50+ dedicated professionals (including CPCS certified staff) maintaining files for over 500 physicians – including approximately 7,000 state licenses and 100,000 privileges.

Each ν Rad radiologist has a CLP support person who ensures all required credentialing, licensing and privileging processes are maintained to The Joint Commission standards.

Primary Source Verifications completed during uRad's credentialing process include:

- Education, medical malpractice coverage, state licensure, entire work history, board certification, references and hospital affiliations.
- NPDB, FSMB, FACIS, OIG, GSA and background checks.
- Prompt site notifications of adverse changes.
- Non-static item reverification every two years.

VRad's Credentialing and Privileging Agreement

- Greatly diminishes Medical Staff Office burden by eliminating the need to independently credential physicians.
- Enables expedited initial appointment and reappointment by allowing the hospital's governing body to grant privileges based on its medical staff recommendations, which rely on information provided by
 *VRad.
- Simplifies adding physicians improving coverage.
- Meets CMS and accrediting body survey requirements.
- VRad's expedited credentialing services are utilized by 60% of VRad client facilities.



Credentialing services as described here are not available in New York, Arkansas or Massachusetts. However, ν Rad offers other tools to make credentialing easier on medical staff offices in those states.
